

2017-2018 KIDS Planned Changes

Introduction

This document outlines the updates and changes to be made to the KIDS Collection System for 2017-2018. Fields are being added and removed resulting in renumbering of many of the data fields. This document references the new 2017-2018 field reference numbering. A conversion chart has been provided and can be found in Appendix A. All other Appendixes are located in the KIDS 2017-2018 File Specification Document.

Modifications to KIDS for 2017-2018 are made because of changes in requirements due to the passing of Every Student Succeeds Act (ESSA), bills passed by the Kansas legislature, and to fulfill the vision of the Kansas State Board of Education.

General Overview

The KIDS 2017-2018 File Specifications document has some new sections that have been added, and the KIDS Submission Overview document will no longer be available.

Data Collections

ASGT, ENRL, EXIT, SMSC, QERY, TASC Collection

No changes will be made.

KCAN Collection

- New Collection for 2017-2018
- Required to be submitted for the following student populations only:
 - Course enrollments and outcomes for Migrant Students to populate the Migrant application.
 - Course outcomes for Career and Technical Education (CTE) students to populate the Pathways application.
 - NEW-CTE Certifications earned by students (formerly collected in the K-PAC application.)
 - Course outcomes for virtual students 19 and over to verify funding amounts.
 - NEW-Course outcomes for students receiving dual credit on high school courses.

STCO Collection

The following changes will be made:

- STCO will no longer be collected in the 2017-2018 school year
- 2016-2017 STCO records will be collected until August 15, 2017.

TEST Collection

The following changes will be made:

 The State History/Government Assessment will be given during the 2017-2018 school year

Data Fields

D2: Accountability School ID

 District Central Office can <u>only</u> be used as the Accountability School for adult students (grade level 18) and pre-kindergarten students (grade 00-04) not on an IEP ('ND' in 32: Primary Disability Code)

D10: Current Grade Level

• Students, age 22 and older as of 10/01/2017, must be submitted as an adult grade level "18"

D18: School Entry Date

- Required on ASGT
- Review Student History Reports for dates

D19: District Entry Date

- Required on ASGT
- Review Student History Reports for dates

D20: State Entry Date

- Required on ASGT
- Review Student History Reports for dates

D35: Residence of Homeless Student while Homeless

Remove text "or is awaiting foster care" from value 4 and 8

D53: Neglected Students

Update definition of Neglected Student

Add Value:

• 3 = Neglected student not receiving Title 1 services

D54: Early Learning Participants

- Collected on ENRL and EOYA
- Indicates that student participates or participated in a district sponsored pre-K program
 - Not Kansas Parent Education Program participants
- Required for students in grades 00-04

Allowable Values for D54:

- 0= No
- 1= Yes

D55: Kansas Parent Education Program Participant

- Collected on ENRL and EOYA
- Indicates that student participates or participated in the Kansas Parent Education program (formerly Parents as Teachers), during the school year
 - Not a sponsored Pre-K program
- Required for students in grades 00-04

Allowable Values for D55:

- 0= No
- 1= Yes

D74-D75: KELPA2 Grouping Indicator 1 and 2

Update assessment name to KELPA2

D79: State History/Government Assessment

- Collected on TEST
- Assessment will be given for the 17/18 school year
- Grade level= 11, 13, or 16

D80: State History/Government Proctor ID

- Must be the ID of the licensed educator who will score the writing portion of the history/government assessment.
- D80 must contain a non-blank value if 2 is selected in D79

D81 & D82: State History/Government Proctor First Name/ Last Name

D81 & D82 must contain a non-blank value if 2 is selected in D79

D92-D95: Kansas English Language Proficiency Assessment

Update assessment name to KELPA2

KCAN Collection

- Focuses on Board Objectives
- Effective for 17/18 School Year
- Same fields as STCO with the changes identified in the KCAN Data Fields section.

KCAN Data Fields

F17: Student is a Single Parent

- Indicator if student is a single parent during the school year the course information is submitted to KSDE
- A student that is a single parent is defined as individuals who are unmarried or legally separated and have custody or joint custody of one or more minor children. This group includes teenagers or women who are pregnant.
- Formerly collected in Pathways application
- Required for Federal Reporting Purposes
- This field is required to have a non-blank value if College/Career indicator of the course is 'F', 'C', 'L' or 'X' in the KCC identifier Allowable Values for F17:
 - Blank = This is not a CTE student
 - 0= No
 - 1= Yes

F19: KCC Identifier

 When reporting CTE Certification data, the KCC Identifier should be 'Certificate'.

F22 Course Status

Indicator of the students status in the course

Add Value

90= Certificate Earned

F25 College Credits Earned

- Indicator of the credits earned by the student for the dual credit college course
- This field is required if College/Career indicator of the course is 'C', 'D', 'L' or 'R' in the KCC identifier

F26 CTE Certification Earned

- Certification code assigned to the certification earned by a student during the current school year
- This field is required if F19: KCC ID = 'Certificate'.
- Formerly collected in K-PAC Allowable Values:
 - See Appendix E
 - Example: Certified Nurses Aid (CNA) = 1042

F27 Date Earned

- Indicator of the date student earned the CTE Certificate
- This field is required if F19: KCC ID = 'Certificate'.
- Formerly collected in K-PAC

F28 Graduation Year

- Indicator of the year the student has or will graduate from high school
- This field is required if F19: KCC ID = 'Certificate'.
- Formerly collected in K-PAC
