

Common KIDS Errors: 2013—2014

Submission Type / Data Element	Error Message In KIDS	Reason for the Error / Example / Notes
D2	Accountability School must contain a valid School ID number belonging to an accredited school or district central office, 0001, or 0002	The Accountability School Identifier must be a valid school identifier within the submitting district as listed in the 2013-2014 Kansas Educational Directory.
D2	Submitter is not a member of the Accountability School.	For most situations, a school or district is only able to send KIDS records with his/her building or a building in the district as the Accountability school. You are not able to send KIDS records with another building listed as the Accountability School.
D2, D15, D16, or F16	Student Attendance School Identifier is not a valid school. Student Accountability School is not a valid school. Attendance/Program Identifier is not a valid school. Accountability School is not a valid school. Funding School is not a valid school. Educator School Identifier is not a valid school.	Enter a valid school/building number in the named field. This will apply to the Accountability School, Funding School, Attendance/Program Identifier, or Educator School Identifier. This error will be returned when the building number sent is not a 4-digit number, not in the Directory Updates application, or when 0001 or 0002 (for some record types) is sent. <u>Example:</u> Accountability School is not a valid school.
D2, D15, D16, or F16	The Educator School Identifier must be active. The Attendance Building ({0}) must be active. The Accountability Building ({0}) must be Active. The Funding Building ({0}) must be Active. The Accountability school identifier must be active, 0001, or 0002.	The school identifier must be an Active building in the Directory Updates application. This error will be returned when the building number that was submitted is for a building that has been closed.
D2, D15, & D16	If Public School submitting, the user must be a member of the Funding building ({0}) or Attendance ({1}) (if Funding = 0003). If Private School submitting, the user must be a member of the Accountability building ({2})	This error message will occur if a public school tries to submit an ENRL record for a student when it is not the funding school for that student OR if a private school submits an ENRL record for a student for whom they are not the Accountability school. Verify that the appropriate building codes have been entered for Accountability School, Funding School, and Attendance School based upon the educational service being provided by your building for the student in question. Example: If Public School submitting, the user must be a member of the Funding building (0102) or Attendance (0103) (if Funding = 0003). If Private School submitting, the user must be a member of the Accountability building (0102)
D2 & D16	The user must be a member of the Accountability School ({0}) or Attendance School ({1}) if Accountability is 0001 or 0002.	The person submitting the record must be associated with the Accountability School or the Attendance School if D2 = "0001" or "0002."

Submission Type / Data Element	Error Message In KIDS	Reason for the Error / Example / Notes
D2 & D16	The Attendance School must contain a valid School ID number belonging to an accredited school or district central office within the submitting district if the Accountability School is 0001 or 0002.	When the Accountability School = "0001" or "0002," the building number for the Attendance School must be for an accredited school building or for the district central office for the submitting district.
D3	Residence District is not a valid district OR The Residence District must be a valid state district, or two-letter state abbreviation	Field Residence District Identifier must have a valid district code. This must be a letter and four digits (i.e., D0323). The most common reason this error occurs is when the letter " O " is used in the digit's placeholder instead of the number " Zero ."
D9 & D18	School Entry Date must be a valid date after the student's birth date.	The School Entry Date cannot be before the student's Date of Birth. You may see this error message paired with another error message. Check the birthdate of the student and the date entered for the school entry date.
D9, D18, & D19	District Entry Date must be a valid date and must be before or the same as School Entry Date and after Student birth date.	The District Entry Date cannot be after the School Entry Date. Also, it can't be before the student's Date of Birth.
D9, D19, & D20	State Entry Date must be a valid date and must be before or the same as District Entry Date and after Student birth date.	The State Entry Date cannot be after the District Entry Date. Also, it can't be before the student's Date of Birth.
D10 & D32	4 year olds at risk cannot have a Primary Disability Code (P.E.) or a Gifted Student Code (S.E.)	The Current Grade Level, with a code " 04 " cannot have an IEP indicated in the Primary Disability Code field. If a student is both At-Risk and has an IEP, use grade level " 02 ".
D10 & D32	If Primary Disability Code is "DD", then the student cannot be 10 years old or older on the date the record is submitted.	When the Primary Disability Code has DD=Developmentally delayed, it is allowed for ages 3-9 only . If the student is 10 years old or older, the IEP must be updated, and the KIDS record sent with the updated code.
D10, D2, D15, & D16	{0 school/building} "{1}" does not have grade level "{2}"	The Current Grade Level indicated on the KIDS record must be included in the grade level range that was listed in the Kansas Educational Directory for the building. This will apply to the Accountability Building, Funding Building, and Attendance Building (D2, D15, and D16). A common issue is when a record is sent to KIDS with a pre-k grade level listed, but the building does not have pre-k included in the grade level range in the Directory. <u>Example:</u> Funding Building "6478" does not have grade level "08"
D10 & D25	In order to mark 1-5 on Concurrent High School Enrollment, Current Grade Level must be 15-18, unless student has a Gifted Student Code (S.E.) of "GI"; in which case Current Grade Level must be 14-18.	Unless the student has been indicated as being a gifted student, KIDS will only accept the Grade Level as 15, 16, 17, or 18. If a student is gifted, the grade level may also be 14.

Submission Type / Data Element	Error Message In KIDS	Reason for the Error / Example / Notes
D13	Invalid State Student Identifier ({0})	The State Student Identifier field must be a valid, 10 digit number that exists in the KIDS Assignment System. Use the "Search Core Data" link in KIDS Collection to search for the correct SSID number if necessary. <u>Example:</u> Invalid State Student Identifier (3035999999)
D13	The State Student Identifier was entered multiple times for this record type.	The State Student Identifier cannot be submitted on more than one record of a particular record type per batch. KIDS will accept files with mixed batch types; however, multiple records of the same type for the same student are not accepted in KIDS. For example, two ENRL records for the same student cannot be sent in the same file or this error will be generated.
D13	The Student State Identifier ({0}) has been retired. The current ID is {0}.	When a student has two different SSIDs, KSDE will investigate and determine which ID should be used and retire the other ID. If the retired ID is sent on subsequent KIDS records, this is the error that will be returned.
D14	Current School Year must be the current program/graduation year.	The Current School Year field must have the current school year submitted. This applies for all submission types except for certain situations for EXIT, ASGT, and STCO. If it is the 2013-2014 school year, enter 2014.
D18	School Entry Date cannot be prior to the school year when the building opened in the Directory Updates application.	The School Entry Date cannot be a date that is before (prior) to the school year when the building is listed as "opened" in the Directory Updates application. The date must be on or after the date listed in the Directory Updates application.
D19	District Entry Date cannot be prior to the school year when the District Central Office building opened in the Directory Updates application.	The District Entry Date cannot be a date that is before (prior) to the school year when the building is listed as "opened" in the Directory Updates application. The date must be on or after the date listed in the Directory Updates application.
D18 & D26	Exit/Withdrawal Date must be on or after the School Entry Date.	When an Exit/Withdrawal Date is sent for a student that is before the date indicated for the School Entry Date, this error will be generated. The student can't withdraw before starting the school.
D20 & D37	If present First Entry Date into a School in the United States must be on or before State Entry Date.	The First Entry Date into a School in the United States is indicated when a student is an ESOL or ESOL eligible student. The date entered for the First Entry Date into a School in the United States must be on or before the date entered in the State Entry Date field.
D21 & D22	Number of Days in Membership must be greater than or equal to Number Of Days Attended.	The valued entered in the Days in Membership field must contain a number equal to or greater than the number enter in the Attendance field.
D21 & D22	Membership Days and Days Attended cannot be zero.	When a student's record is sent on an EOYA or TITL submission, these fields must have a value greater than zero.
D24 & D40	ESOL Contact Minutes are greater than Minutes Enrolled.	The amount of time indicated for ESOL Contact Minutes can't be more than the amount of time indicated for Minutes Enrolled.

Submission Type / Data Element	Error Message In KIDS	Reason for the Error / Example / Notes
D39 & D36-D40	If ESOL Program Participation Code is 1, 2, or 3, ESOL Program Entry Date, US Entry Date, First Language, and ESOL Contact Minutes must contain valid nonblank values.	All the ESOL fields are connected, and what you enter in one field may be dependent upon what was entered in another one. See the ESOL Field Requirements table in the KIDS 2013-2014 Collection System File Specifications document.
D39 & D36-D40	If ESOL Program Participation Code is 0 or Blank, ESOL Program Entry Date, US Entry Date, and ESOL Contact Minutes must be blank.	All the ESOL fields are connected, and what you enter in one field may be dependent upon what was entered in another one. See the ESOL Field Requirements table in the KIDS 2013-2014 Collection System File Specifications document.
D39 & D36-D40	If ESOL Program Participation Code is 4, 5, or 6, ESOL Program Entry Date, US Entry Date, and First Language must contain valid nonblank values.	All the ESOL fields are connected, and what you enter in one field may be dependent upon what was entered in another one. See the ESOL Field Requirements table in the KIDS 2013-2014 Collection System File Specifications document.
D39 & D83	If "1" is entered on KELPA, ESOL/Bilingual Program Participation Code must equal 1 - 4 or 6.	The Kansas English Language Proficiency Assessment (KELPA) field is an indication of the test type the student will take in this subject area. ESOL/Bilingual Program Participation Code indicates the program the student participates in. In order to select "1" for KELPA, a student must be marked as "1"-"4" or "6" for the ESOL/Bilingual Program Participation Code.
D39 & D83	The entered KELPA value requires an empty ESOL/Bilingual Program Participation Code or "5"	The Kansas English Language Proficiency Assessment (KELPA) is an indication of the test type the student will take in this subject area. ESOL/Bilingual Program Participation Code indicates the program the student participates in. In order to select "2" for KELPA, a student must have a blank value or be marked as "5" for the ESOL/Bilingual Program Participation Code.
D43& D44	Transportation FTE and Miles Transported must both be zero or both greater than 0.	Both the Transportation FTE and Miles Transported fields, must contain a valid numeric value. Both fields must be zero or both greater than 0. In order to indicate a student is being transported (Transportation FTE) the number of miles transported must also be reported.
D43, D45, D46, & D47	Address information is required as Miles Transported is equal or over 2.5 miles.	When Miles Transported is more than 2.5 miles, then valid values are required for the Student's Transportation Street Address, Student's Transportation City, and Student's Transportation Zip Code fields.
D47	Error in ZIP Code - expected 99999 or 99999-9999.	The format for the Student's Transportation Zip Code must be a 5 digit or 9 digit value or this error will be generated.
D50 & D51	Country of Birth is required if a value of "1" or "2" is reported for Immigrant Student.	When a student has been reported as being an Immigrant Student, then a valid value (Not any of the 50 United States, the District of Columbia, or Puerto Rico) must be entered for the Country of Birth.
ASGT	Current School Year must be from the current program/graduation year to the current program/graduation year plus one.	A valid school year is defined as a 4 digit year that is equal to the current calendar year or the current school year + 1. For example, the error message will occur when an ASGT Record is submitted with 2009 as the current school year. Only 2014 or 2015 are considered valid values for the 2013-2014 school year on ASGT records.

Submission Type / Data Element	Error Message In KIDS	Reason for the Error / Example / Notes
ENRL D15	Funding Building must be an accredited building, Central Office, or Juvenile Detention.	The Funding School must be an accredited school identifier within the submitting district as listed in the 2013-2014 Kansas Educational Directory.
ENRL D10 & D32	If Primary Disability Code is "DD", then the student cannot be 10 years old or older on September 20.	When the Primary Disability Code has DD=Developmentally delayed, it is allowed for ages 3-9 only. If the student is 10 years old or older, the IEP must be updated, and the KIDS record sent with the updated code. This applies to ENRL records only.
EOYA D32 & D34	Primary Disability requires a "1" in the Qualified for 504 field. ;Students with disabilities must be marked as "Qualified for 504".	A valid value in the Primary Disability Code field means that a student should also have a non-zero value in the Qualified for 504 field even if they do not have a 504 plan in place.
EXIT D14	Current School year must be from the current program/graduation year minus 1 and the current program/graduation year.	A valid school year is defined as a 4-digit year that is equal to the current calendar year or the current calendar year minus 1. EXIT records can only have 2014 or 2013 entered in the Current School Year field or this error will be generated.
EXIT D27 & D29	If Post-Graduation Plans is '9', then the Exit/Withdrawal Type must be '22' on EXIT records.	The value of "9" for Post-Graduation Plans is only available for students with disabilities who met the district graduation requirements for a regular diploma, but is remaining in school to receive transitional services which is indicated in by the value of "22" for the Exit/Withdrawal Type.
EXIT D27 & D29	Post-Graduation Plans cannot be empty if the Exit/Withdrawal is a graduation.	When a student has a value of "8" to indicate a Graduate in the Exit/Withdrawal Type field, then the Post-Graduation Plans field must have a valid value or this error will be generated.
EXIT D26, D27 & D29	Exit/Withdrawal Information is only allowable on EXIT record types	The Exit/Withdrawal Date, Exit/Withdrawal Type, or Post-Graduation Plans fields cannot be submitted on non-EXIT record types (i.e. ENRL, ASGT, etc.). If you need to EXIT a student and you have another record type to submit for that student, there must be two different records sent. You are not able to send EXIT data on another type of KIDS record.
EXIT D22 & D32	If Exit/Withdrawal Type is '22' then Primary Disability Code must contain a valid non-blank value.	The value of "22" for Exit/Withdrawal Type is only available for students with disabilities who met the district graduation requirements for a regular diploma, but is remaining in school to receive transitional services. This means that in order to indicate "22" for Exit/Withdrawal Type, the Primary Disability Code field must have a valid non-blank value or this error will be generated.
EXIT D26	Exit Records cannot be submitted with Exit Withdrawal Dates prior to (10/1/2012) for this building.	The date entered as the Exit/Withdrawal Date for anything other than a date after September 30 of the previous school year will be rejected if it was submitted before the Dropout Graduation Summary Report has been submitted.
EXIT D26	Exit Records cannot be submitted with Exit Withdrawal Dates prior to (10/1/2013) for this building.	The date entered as the Exit/Withdrawal Date for anything other than a date after September 30 of the current school year will be rejected if it was submitted after the Dropout Graduation Summary Report has been submitted.

Submission Type / Data Element	Error Message In KIDS	Reason for the Error / Example / Notes
EXIT D27	Only students with a Current Grade Level greater than 13 can have an Exit Withdrawal Type of 8 or 22.	In order to indicate that a student has exited as a 8=Graduated with regular diploma or 22=Student with disabilities who met the district graduation requirements for a regular diploma, but is remaining in school to receive transitional services deemed necessary but the IEP team., the student must have a Grade Level of 14 (Ninth Grade) or above or this error will be generated.
MILT D10 & D32	If Primary Disability Code is "DD", then the student cannot be 10 years old or older on February 20.	When the Primary Disability Code has DD=Developmentally delayed, it is allowed for ages 3-9 only. If the student is 10 years old or older, the IEP must be updated, and the KIDS record sent with the updated code. This applies to MILT records only.
TEST D10	The grade level can only be K-12	The Grade Level field can only be "05" through "17" on a TEST record. If a TEST record was submitted for a pre-kindergarten student (grade levels 00-04) or Not Graded student (grade level 18) in field D10, you would see this error.
TEST D10 & D74-D83	Assessment selection requires {0}.	The value entered in one of the assessment fields is only available for students in a certain KIDS Grade Level. The D10: Current Grade Level field must align with the grade level allowed for that test type. <u>Example:</u> Assessment selection requires 9th or 11th grade.
TEST D32, & D74-D82	To mark an Assessment with a "3 = Alternate", the Primary Disability Code must contain a non-blank value.	The value entered in one of the assessment fields indicates an alternate assessment. However, the student is not a SPED student as indicated in the Primary Disability Code field. The student needs to either have an indication of a disability or have the test type changed.
QUERY	(Not an Error) The QUERY process found no matches.	The core student data that was sent on the QUERY record does not match the data that is currently in the KIDS Assignment System. This is a good indication that the student is new to KIDS and needs to have an ASGT record sent so that an SSID can be assigned.
Multiple fields and record types	{0} was not in the list ({1})	The data in the named field must be an entry in the specified list of values. There are many fields that will utilize this error message when a value was sent is not an value that is allowed. Check the named field's list of allowable values in the KIDS Collection System File Specifications. <u>Example:</u> Primary Disability Code was not in the list (AM, DB, DD, ED, HI, ID, LD, MD, OH, OI, SL, TB, VI)
Multiple fields and record types	Field is too long: {0}	This error occurs when data is sent that contains more characters than the 'Maximum Length' as indicated in the KIDS File Specifications document. Change the named field to contain all digits and ensure that the number of digits entered are correct. <u>Example:</u> Field is too long: Student Comprehensive Race
Multiple fields and record types	{0} is after submission date	The named field is a date field. The entered date is after the batch submission date. The date must be on or before the batch submission date. <u>Example:</u> School Entry Date is after submission date.

Submission Type / Data Element	Error Message In KIDS	Reason for the Error / Example / Notes
Multiple fields and record types	{0} is greater than the maximum value of {1}	The data in the named field must be less than or equal to the specified value. <u>Example:</u> Transportation FTE is greater than the maximum value of 1
Multiple fields and record types	{0} is less than minimum of {1}	The data in the named field must be greater than or equal to the specified value. <u>Example:</u> Student Comprehensive Race is less than minimum of 0000
Multiple fields and record types	{0} is not a valid entry.	The named value is not valid for the named field. The field must contain a valid value that is defined for that field in the KIDS File Specification document. Several fields may display this error when an invalid value is sent: Current School Year, Comprehensive Race, and Cumulative Attended Days. <u>Example:</u> Student Comprehensive Race is not a valid entry.
Multiple fields and record types	Invalid value for Comprehensive Race	This error occurs when the number '1' does not appear as one of the five Comprehensive Race positions. When '00000' is sent, this error is generated. The value of "1" must be in one of the positions for Comprehensive Race.
Multiple fields and record types	Date format error ({0})	Date must be in the format mm/dd/yyyy. This error will occur when a date field has data that does not match the proper format (9/1/93 rather than 09/01/1993). The error may occur for any Date field. <u>Example:</u> Date format error (Birth Date)
Multiple fields and record types	Missing field: {0}	The data in the named field is missing and must be supplied in order for the file to be processed. <u>Example:</u> Missing field: Legal Last Name
Multiple fields and record types	Mismatch on student element ({0})	The data uploaded in this record is different than the core student data that currently exists in the "Assignment System" for this student. The specific "Assignment System" core student data elements that do not match are displayed in parentheses. If the data that you submitted to KIDS is correct, update the data in the "Assignment System" by completing the Manage Core Data Process . If the data you submitted to KIDS is incorrect, return to your student information system to make corrections and then upload a new batch file. <u>Example:</u> Mismatch on student element (Grade Level(07), DOB(11/04/1999))
Multiple fields and record types	This Record Type/Submission {0} is locked for the school year indicated on the record.	Submission for the "record type" in the batch uploaded is locked. A batch being uploaded outside the submission window will trigger this error. This error may also occur if something else has closed the submission. <u>Example:</u> Once the PBR has been submitted, no ENRL record will be accepted and the error message will say: This submission type ENRL is locked for the school year indicated on the record.

Submission Type / Data Element	Error Message In KIDS	Reason for the Error / Example / Notes
Multiple fields and record types	Number format error ({0})	This error occurs when alphanumeric values are used instead of numeric values.
STCO F12	Grade Percent is not a valid entry.	Field F12: Grade Percent must be in the range of 0.0 to 125.0%. A percent submitted in the field must be rounded to the nearest tenth percent.
STCO F12, F13, F16-19, & F23	The Student/Course/Teacher Information was entered multiple times for this record type.	STCO records must be unique and are considered "unique" by the following fields-- F12: State Student Identifier, F13: School Year, F16: Educator School Identifier, F17: KCC Identifier, F18: Course Section, F29: Local Course ID, and F23: Educator ID. If multiple records with values matching in those fields are submitted together in the same batch, this error will be generated.
STCO F13	Current School Year must be the current program/graduation year.	2013-2014 STCO records can only be submitted from 8/15/13 through 8/15/14. The F13: School Year must be '2014.'
STCO F16	The user must be a member of the building submitted.	STCO records can be submitted only by the school listed as F16: Educator School Identifier on the STCO record or the district that contains the school listed as F16. If an STCO record is submitted by a school (or associated district) other than that listed as the F16: School Identifier, the record will be rejected and this error will be generated.
STCO F17	KCC Identifier is not a valid entry.	The KCC Identifier field must be in the correct format. The validation is checking to see if the letters and numbers are in the correct place. This is field is case sensitive.
STCO F20 & F21	If '01' or '02' is indicated on Course Status, a value is required in either Letter Grade or Percent Grade.	The Course Status field will indicate "01" or "02" if the student completed the class. When a "01" or "02" is indicated in the Course Status field, a valid value must be present in either the Letter Grade field or the Percent Grade field.
STCO F20 & F21	If a non-blank value is entered in Letter Grade then Course Status must be '01' or '02'.	If the Letter Grade field has a non-blank value, then the Course Status field must be '01' or '02' to indicate whether the student passed or failed the course.
STCO F20 & F22	If a non-blank value is entered in Percent Grade then Course Status must be '01' or '02'.	If the Percent Grade field has a valid non-blank value, then the Course Status field must be '01' or '02' to indicate whether the student passed or failed the course.
STCO F22	Grade Percent is greater than the maximum value of 125.0	The percent that is sent in this field must be 125% or lower. The system will not accept a value that is higher than that.
STCO F23	Invalid Teacher Identifier ({0}).	The Teacher Identifier field must have a valid 10-digit identification number. This number may also be a 9-digit social security number if the teacher is a non-licensed educator.

Submission Type / Data Element	Error Message In KIDS	Reason for the Error / Example / Notes
STCO F23	The 9-digit number entered does not match the Educator Data Collection System (EDCS) or the SSN has an Educator ID associated with it in EDCS.	When a social security number is used for the Educator Identifier, it must match what has been entered in the Educator Data Collection System (EDCS) OR that social security number has an educator ID associated with it in EDCS. If there is an educator ID associated with it in EDCS, then the educator ID must be used on the KIDS STCO record.
STCO	The teacher/course combination does not match between EDCS and STCO.	This error is a general message indicating that something is not in alignment when validated against the course assignment to the educator in EDCS. Generate the "Info for STCO" report in KIDS. The report contains all of the course assignments that have been entered in EDCS for teachers and have the "Confirm for STCO" checkbox marked. You should be able to identify and correct any discrepancies with this report.
