



2018-2019 KIDS Planned Changes

Introduction

This document outlines the updates and changes to be made to the KIDS Collection System for 2018-2019. Fields are being added and removed resulting in renumbering of many of the data fields. This document references the new 2018-2019 field reference numbering. A conversion chart has been provided and can be found in Appendix A.

Modifications to KIDS for 2018-2019 are made because of changes in requirements due to the passing of Every Student Succeeds Act (ESSA), bills passed by the Kansas legislature, and to fulfill the vision of the Kansas State Board of Education.

General Overview

The KIDS 2018-2019 File Specifications document has updated values and fields to reflect changes for the upcoming school year.

- Allows student to be entered into Sped-Pro without claiming the student
- Students must be marked WD = Yes, is on an IEP and receives special education services in field D32 – Primary Disability Code.

D10: Current Grade Level

- Update to field description language. Language updated to align programs better in this description. This change does not affect any reporting. Only more clarifying language.

D14: Current School Year

- Update language to current school year, 2019.

D39: ESOL/ Bilingual Program Participation Code

- Remove Value 4 = Monitored ESOL student (status after scoring a “3/Proficient” based on proficiency determination results from the Kansas English Language Proficiency Assessment (KELPA2) two consecutive years). Students are listed as monitored status for no more than two years after they stop receiving ESOL services.
- Add Value 7= Transitional year, student based on scoring 3/Proficient on last year’s KELPA2.If the student receives minutes, add minutes served to field D41.
- Add value 8= Monitored ESOL student after transition year (status after scoring a “3/Proficient” based on proficiency determination results from the Kansas English Language Proficiency Assessment (KELPA2) one year). Students are listed as monitored status for no more than two years after they stop receiving ESOL services.

D40: ESOL Bilingual Program Ending Date

- Updated definition of program end date to reflect one year proficiency and transitional year.

D54: Early Learning Participant

- Field name change to Kansas Preschool Program (KPP)

D55: Kansas Parent Education Program Participant

- Field name change to Kansas Parents as Teachers (KPAT)

D72: State History/ Gov Assessment

- Updated language to no assessment in this content area.

D73: General CTE Assessment

- Remove value 3= Yes, test in this content area with Career Competency Qualifier (CCQ)
- Remove value 6= No assessment, Career Competency Qualifier only

D74: Comprehensive Agriculture Assessment

- Remove value 3= Yes, test in this content area with Career Competency Qualifier (CCQ)
- Remove value 4= Yes, test in this content area with Power, Structural, and Technical Systems module and Career Competency Qualifier (CCQ)
- Remove value 6= No assessment, Career Competency Qualifier only
- Remove value 7= No assessment, Power, Structural, and Technical Systems module and Career Competency Qualifier

D75: Animal Systems Assessment

- Remove value 3= Yes, test in this content area with Career Competency Qualifier (CCQ)
- Remove value 6= No assessment, Career Competency Qualifier only

D76: Plant Systems Assessment

- Remove value 3= Yes, test in this content area with Career Competency Qualifier (CCQ)
- Remove value 4= Yes, test in this content area with Power, Structural, and Technical Systems module and Career Competency Qualifier (CCQ)
- Remove value 6= No assessment, Career Competency Qualifier only
- Remove value 7= No assessment, Power, Structural, and Technical Systems module and Career Competency Qualifier

D77: Kansas English Language Proficiency Assessment (KELPA2)

- Update language to reflect new ESOL program participation codes. Removed verbiage on Value 4.

D81: American College Testing (ACT) Assessment

- Field added an indication the student will take the American College Testing (ACT) Assessment during the current school year. In order to have a value other than '0' in this field, D10: Current Grade Level must equal 16.

D82: ACT WorkKeys Assessment

- Field added an indication the student will take the ACT WorkKeys Assessment during the current school year. In order to have a value other than '0' in this field, D10: Current Grade Level must equal 16.

C13: School Year

- Update language to current school year, 2019.

KCAN Data Fields

F13: School Year

- Update language to current school year, 2019.

F29: First Instruction Date

- Field added for federal migrant reporting. This field is the first day of migrant student instruction for the current school year. Required if F16: Migrant Student has a value of “1” = Yes.

F30: Last Instruction Date

- Field added for federal migrant reporting. This field is the last day of migrant student instruction for the current school year. Required if F16: Migrant Student has a value of “1” = Yes.

F31: Instructional Minutes Completed

- Field added for federal migrant reporting. The number of minutes completed by a migrant student upon Exit. Required if F16: Migrant Student has a value of “1” = Yes and F22: Course Status “04” = Exited before course completion

F32: User Field 1

- Renumbered due to new fields being added.

F33: User Field 2

- Renumbered due to new fields being added.

F34: User Field 3

- Renumbered due to new fields being added.
