The District ADA calculation represents attendance from the beginning of the school year through November 30th of the school year.

Report Name: Student Attendance Ratio Report

Report Description: This report includes the days in attendance data, the days in membership data, and the attendance ratio (days in attendance ÷ days in membership) for each individual student. This report will allow the user to sort the attendance ratios from smallest to largest so that they can quickly identify attendance and membership data that may be inaccurate. Corrections can then be made through the submission of updated KIDS EOYA records. Note: This report is primarily a tool to help schools submit accurate attendance and membership data for each individual student. The average of the total attendance ratios for all students will not equal the attendance rate calculation.
