



## KIDS Collection 2023-2024 Planned Changes

### **Introduction**

This document outlines the updates and changes to be made to the KIDS Collection System for 2023-2024 SY.

Modifications to KIDS for 2023-2024 SY are made because of changes in requirements due to the passing of Every Student Succeeds Act (ESSA), bills passed by the Kansas legislature, and to fulfill the vision of the Kansas State Board of Education.
