



## 2019-2020 KIDS Planned Changes

### Introduction

This document outlines the updates and changes to be made to the KIDS Collection System for 2019-2020. Fields are being added and removed resulting in renumbering of many of the data fields.

Modifications to KIDS for 2019-2020 are made because of changes in requirements due to the passing of Every Student Succeeds Act (ESSA), bills passed by the Kansas legislature, and to fulfill the vision of the Kansas State Board of Education.

### General Overview

The KIDS 2019-2020 File Specifications document has updated values and fields to reflect changes for the upcoming school year.
